**HUNTER REQUIREMENTS:**

1. Hunter must be registered and cleared by the Aurora Police Department.
2. Hunter must have permission of property owner.
3. **Hunter must have an Ohio State Hunting License, State Deer Permit, copy of Photo ID, photo copy of Ohio State License and Deer Permit must accompany application. (State requirements on land ownership exemption do apply.)**
4. **A minimum of 8 acres of land in single ownership is required, or 8 acres continuous of two adjacent property owners.**
5. Hunter must report all deer taken to the Aurora Police Department.
6. Hunter must carry Deer Hunting Permit issued by the City of Aurora with him/her.
7. Hunter agrees to comply with all City and State Requirements, Ordinance 1996-210.
